

# US 287 RESURFACING PHASE II HIGHWAY CONSTRUCTION UPDATE

## Project Overview:

In September 2014, the Colorado Department of Transportation (CDOT) began resurfacing a four-mile segment of US 287 from 29th Street in Loveland north to State Highway (SH) 392 in Fort Collins. Crews are currently repaving and resurfacing US 287 between MP 335.23 and MP 339.2. The project will improve the highway by replacing the existing asphalt with new, longer-lasting asphalt materials to create a smoother driving surface for travelers.

Additionally, the intersection of US 287 and SH 392 has undergone major construction activities. The turn lanes have been widened, the drainage system surrounding the highway has been improved and concrete pavement is being placed in the intersection.

Completion of the project will mean a safer trip through the corridor for motorists. Improved drainage will reduce the severity of flooding along the highway and the wider turn lanes will better accommodate large trucks that utilize the highway system.

Coulson Excavating of Loveland is the contractor for the \$6.3 million project, which is funded by CDOT.

## Construction Progress and Timeline:

Preliminary work on Phase II officially began in September 2014, as crews completed much of the concrete repair work between 29th Street and 71st Street, including installing and updating pedestrian ramps.

As of the second week of May, milling and initial paving on US 287 from Garfield Avenue to 57th Street is complete. Crews will begin milling on US 287 between 57th Street and Midland Drive on Monday, May 18. Once milling is complete, initial paving will commence.

The intersection at US 287 and SH 392 (Carpenter Road) is open, and traffic lights have been installed. However, left turns are not allowed from Southbound US 287 onto Eastbound SH 392 (Carpenter Road). Those wishing to turn East onto SH 392 (Carpenter Road) should utilize Trilby Road.

All construction for Phase II is expected to be completed by the end of summer 2015.

### **Traffic Impacts:**

There will be various lane closures between 29th Street and SH 392 (Carpenter Road) during milling and paving. Motorists are advised to seek alternate routes during these times. During paving operations, there will be wet tack on the roadway that can damage vehicles. Traffic impacts continue to affect the intersection of US 287 and SH 392. Motorists are unable to turn east onto SH 392 via US 287, and US 287 is restricted to one lane in each direction at the intersection. A detour utilizing Trilby Road and LeMay Avenue is recommended.

### **ATTENTION TRUCKERS:**

There is an oversized vehicle restriction on US 392 (Carpenter Road). No vehicles over 50 feet long and/or 11 feet wide are allowed on Westbound SH 392 (Carpenter Road). Motorists are advised to utilize Trilby Road as a detour.
